

Center for the Arts - Rental Rates January 1, 2016

Local Use – Organizations & Individuals based within Gunnison County

These rates are based on events lasting up to three hours. Uses that extend longer will incur an additional fee of \$100 per hour. These rates do not include fees for technical services (\$30.00 per hour, minimum three hour charge) or for contract security staff (\$35 per hour per person). An additional cleaning fee of \$30 per hour will be required for food and/or beverage receptions. The Center holds a state liquor license in good standing and may, at staff's discretion, operate the bar for events with Center bartenders. All bar proceeds are retained by the Center. No alcohol may be brought in or removed from the premises.

Local Schools

Performance / Event	\$100 per event when admission is FREE; \$150 per event when admission is charged or admission with donation
Rehearsals	\$15/hour or \$50/day
Outdoor Stage	\$200 for use of Center's covered stage with electricity only; \$350 for outdoor stage, electricity and use of inside space (dressing rooms and backstage only). All events on the outdoor stage must be approved by Town of Crested Butte Director of Parks & Recreation and the Crested Butte Town Council. Technical needs for outdoor events must be discussed and approved by the Rental Manager.

Local Non-Profits

Performance / Event	Contract signatory must present a current 501(c)3 certificate 20% of gross ticket sales or \$250 per event, whichever is greater
Rehearsals	\$20/hour or \$80/day
% Waived Rate:	If the rental period involves two or more weeks of use OR is a fundraiser for a local non-profit, the 20 % of gross ticket sales provision may be waived and the daily rate is \$450.
Outdoor Stage	\$300 for use of Center's covered stage with electricity only; \$450 for outdoor stage, electricity and use of inside space (dressing rooms and backstage only). All events on the outdoor stage must be approved by Town of Crested Butte Director of Parks & Recreation and the Crested Butte Town Council. Technical needs for outdoor events must be discussed and approved by the Rental Manager.

Local For-Profit Organizations or Individuals

Performance / Event	\$450 per event (lasting up to three hours)
Rehearsals	\$40/hour or \$150/day
Outdoor Stage	\$400 for use of Center's covered stage with electricity only; \$550 for outdoor stage, electricity and use of inside space (dressing rooms and backstage only). All events on the outdoor stage must be approved by Town of Crested Butte Director of Parks & Recreation and the Crested Butte Town Council. Technical needs for outdoor events must be discussed and approved by the Center for the Arts.

Private Party:

\$90 outside of regular business hours, \$60 during regular business hours

Out-of-Area Renter – Organizations & Individuals based outside Gunnison County

Performance / Event \$600 per event

Rehearsals \$100/hour or \$300/day

Outdoor Stage \$500 for use of Center's covered stage with electricity only; \$750 for outdoor stage, electricity and use of inside space (dressing rooms, etc). All events on the outdoor stage must be approved by Town Director of Parks & Recreation and the Crested Butte Town Council. Technical needs for outdoor events must be discussed and approved by the Center for the Arts.
